

from here. Access to new markets is
exceptional.



AIR TRAVEL: Your people can reach more than 75 countries and 150 U.S. cities every day – without ever changing planes – from Atlanta's Hartsfield-Jackson International Airport. More than 80 percent of U.S. markets are within a two-hour flight, and non-stop flights are available throughout the day and evening to major cities like New York and Chicago.

SEA CARGO: Georgia has not one but two deepwater ports, Savannah and Brunswick, and they serve all major ocean carriers and 100-plus trucking companies. Savannah is the fourth largest and fastest-growing container port in the U.S. for the past 10 years – and is a major reason Georgia now ranks no. 2 nationally in exports.

RAIL: With 5,000 miles of rail track, Georgia boasts one of the nation's most extensive rail systems for moving freight. And rail integrates with shipping on the Georgia coast in a big way: Savannah is the largest intermodal hub in the Southeast. It's also one of a very few U.S. ports to have two class-1 railroad facilities on terminal (CSX and Norfolk Southern).

TRUCKING: Four major U.S. interstates go through Georgia, allowing you to reach 80 percent of U.S. markets in two days or less. In fact, Georgia's centralized location in the Southeast gives you a strategic advantage.

THE GEORGIA ECONOMY IS FORWARD-LOOKING.

Georgia consistently ranks high in life science activities, entrepreneurship and technology-focused industries. Universities are nationally known for being collaborative. And the state is now aggressively pursuing more opportunities on behalf of business through The Georgia Competitiveness Initiative, a business-government partnership developing a blueprint for 21st century growth.

The money you save will be significant – and could be tremendous.

TAXES: Georgia's low corporate tax rate – 6 percent – applies only to the portion of income earned inside the state. And your corporate income tax liability is lowered further if your company delivers a large portion of products and services to places outside the state.

LABOR: Georgia has an abundance of high-quality, affordable labor. Georgia's hourly manufacturing wage in 2010 was nearly 11 percent lower than the national average. The state has the second-lowest union membership rate in the U.S. – 4 percent of employed – and Georgia is a right-to-work state.

COST OF LIVING: The cost of living in all eight of Georgia's largest cities, including Atlanta, is below the national average, according to the ACCRA Cost of Living Index. And a 2010 KPMG study ranked Atlanta as the second least expensive large U.S. city for business. Georgia's home prices are also below the national average.

INCENTIVES: Companies in several strategic industries and sectors qualify for up to five years of tax credits when they create jobs – as much as \$4,000 per job, per year.

- Application of tax credits against payroll withholding tax to generate cash flow for companies.
- Georgia's Foreign Trade Zone program allows qualified companies to defer, decrease or eliminate duties on materials imported from overseas to make products in Georgia.
- Operate in Georgia for at least three years and make a qualified new investment of at least \$50,000 in manufacturing or telecommunications, and you can get a tax credit between 1 and 5 percent of your investment.

About that last point – incentives – there are so many other ways your company could add to the bottom line. Your Georgia Department of Economic Development consultant will work with you to identify them.


INFLUX: People are coming to Georgia, not leaving it. Some 54,000 new residents arrive each year, and the state added more than 1.5 million residents between 2000 and 2010. More important, population is projected to grow by 46 percent between 2010 and 2030.

PIPELINE OF TALENT: Nearly 90 accredited universities, colleges and technical colleges produce 50,000-plus graduates a year. Georgia's university system is one of the largest in the U.S.; moreover, colleges and universities in the Atlanta region rank in the top 10 in enrollment, degrees conferred and 20 other measures of educational strength.

DEVELOPMENT AND TRAINING: Georgia Quick Start is widely regarded as one of the nation's top-ranked workforce training programs. It provides customized training free-of-charge to qualified companies, and major corporations from Kia to IKEA have reaped benefits from Quick Start. Similarly, Georgia's Intellectual Capital Partnership Program (ICAPP) offers qualified companies customized, accelerated education for knowledge workers in high-demand occupations.

CLIMATE: Georgia is colored by four well-defined seasons, including a brief winter, with an average temperature of 41°F/5°C, and a warm summer, with an average temperature of 82°F/28°C. Autumn and spring are spectacular.

SPORTS: World-class sporting events are right at home in Georgia, from the annual Masters Golf Tournament to NASCAR auto racing. Professional teams come to Atlanta to take on the Braves, Falcons and Hawks.

RECREATION: The Georgia outdoors offers something for everyone - pristine beaches, wondrous forests, majestic mountains and magnificent rivers and streams. Georgia is also home to more than 60 state parks and a dozen national parks, including the world-famous Okefenokee Swamp, as well as the world's largest aquarium.


