"Emerson made this investment because we believe Ciudad Acuña has a bright future ahead as a manufacturing location that enables us to meet global demand for our Metro storage products in a cost-competitive manner," said Mr. Monser. "We appreciate the welcoming approach of local leaders who convinced us to locate here."

Mr. Nackley echoed those comments and added: "We look forward to making the highest quality and innovative products here in Ciudad Acuña to serve the needs of our customers in the foodservice, commercial and healthcare markets.
