

#### THE TAC LOGISTICS ADVANTAGE: Where I-30 \* I-49 \* I-69 Meet

TexAmericas Center is located in the Texarkana, TX-AR MSA. Texarkana is the front door to Texas, and is the lowest aggregate mile location in the State of Texas to serve the US market, as it is the closest city in Texas to the geographic and population centers of the US. All Texas routes identified as NAFTA corridors exit Texas through Texarkana.

Texarkana/TexAmericas Center was ranked a 10 out of 10 for Distribution, Fulfillment, Logistics, Warehouse and Wholesale Operations (Targeted Industry Analysis, 2017). TexAmericas Center is located within 500 miles of:

- 23 MSAs having a population of over 450,000 residents
- 10 of the fastest growing MSAs in the US market
- 53.8 million people, 10 million more individuals than the Dallas, Texas, 500mile reach

#### <u>I-30</u>

TexAmericas Center is located along I-30. TAC's most central interchange is within 0.05 miles of the property and it is about two hours travel time along I-30 from both Dallas (west) and Little Rock (east).

#### <u>I-69/I-369</u>

Interstate I-69/I-369 is within 8 miles of TexAmericas Center and is about five and a half hours north of Houston on U.S. 59, soon to be I-69/I-369. I-69 also connects with all Texas ports on the Gulf of Mexico. A proposed extension off I-369 will run northwest through the TexAmericas Center Industrial Park, and swing northeast and connect to I-49 north of Texarkana.

#### <u>I-49</u>

TexAmericas Center is within 13 miles of I-49 and is approximately six and a half hours north of New Orleans on I-49. To the north, roughly 150 miles of I-49 remain to be constructed. This interstate will link Texarkana to Kansas City and its connections to Canada and beyond.

## Incentives (cont)

#### FOREIGN TRADE ZONE

- Duty Exemption: no duties or quota charges on re-exports. No duty is paid on goods destroyed in the zone, which can benefit a company with fragile imports or with manufacturing processes that result in large amounts of scrap.
- **Duty Deferral:** customs duties and federal excise tax deferred on imports until they leave the zone and enter the U.S. Customs territory.
- Duty Reduction (Inverted Tariff): the finished product may be entered into the U.S. Customs territory at the duty rate that applies to its finished condition. Moreover, duty is not owed on labor, overhead or profit attributable to zone production operations.

#### **OPPORTUNITY ZONE BENEFITS**

Investments made in an Opportunity Zone and through an Opportunity Fund offers these three tax incentives for capital gains:

- Temporary Deferral an investor can defer capital gains taxes by putting and keeping unrealized gains in an Opportunity Fund.
- Reduction the original amount of capital gains on which an investor has to pay deferred taxes is reduced by 10% if the Opportunity Fund investment is held for 5 years and another 5% if held for 7 years.
- Permanent Exclusion any capital gains on investments made through the Opportunity Fund accrue tax-free as long as the investor holds them for at least 10 years.
