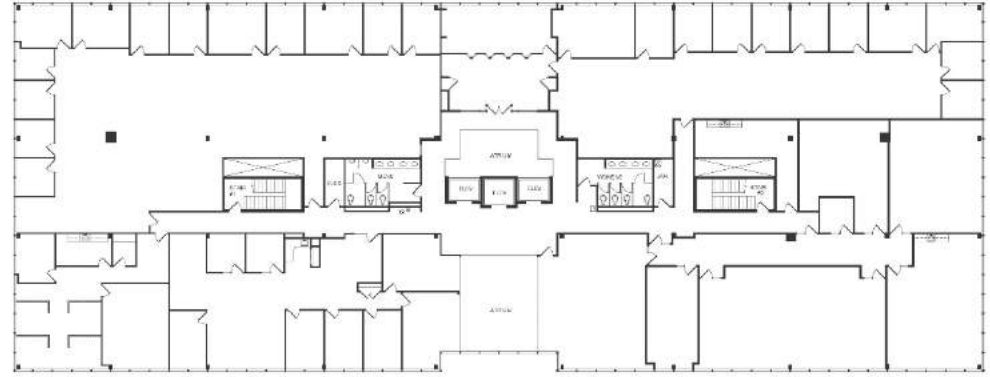

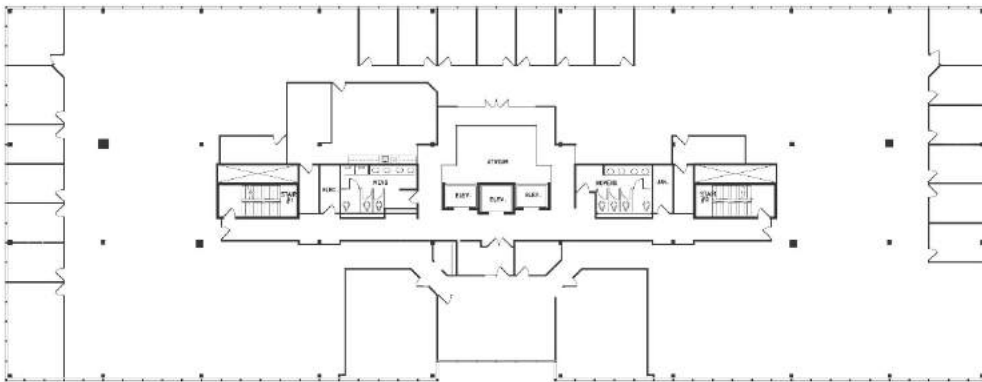
First Floor - 21,631 RSF



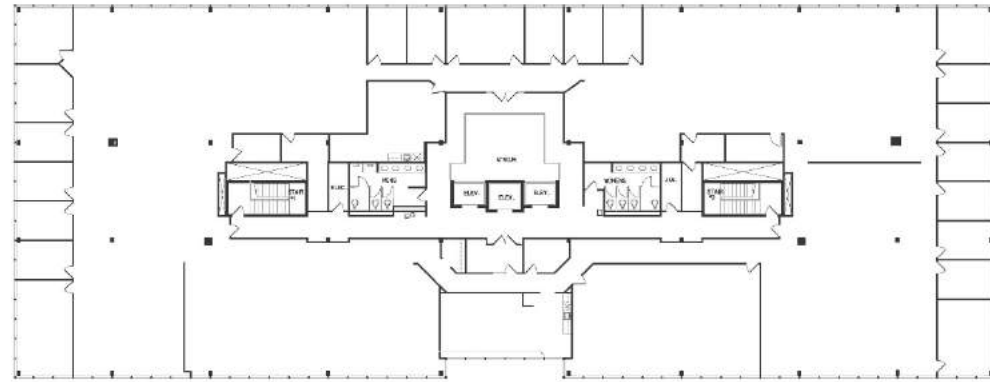
Second Floor - 22,822 RSF



Third Floor - 23,286 RSF



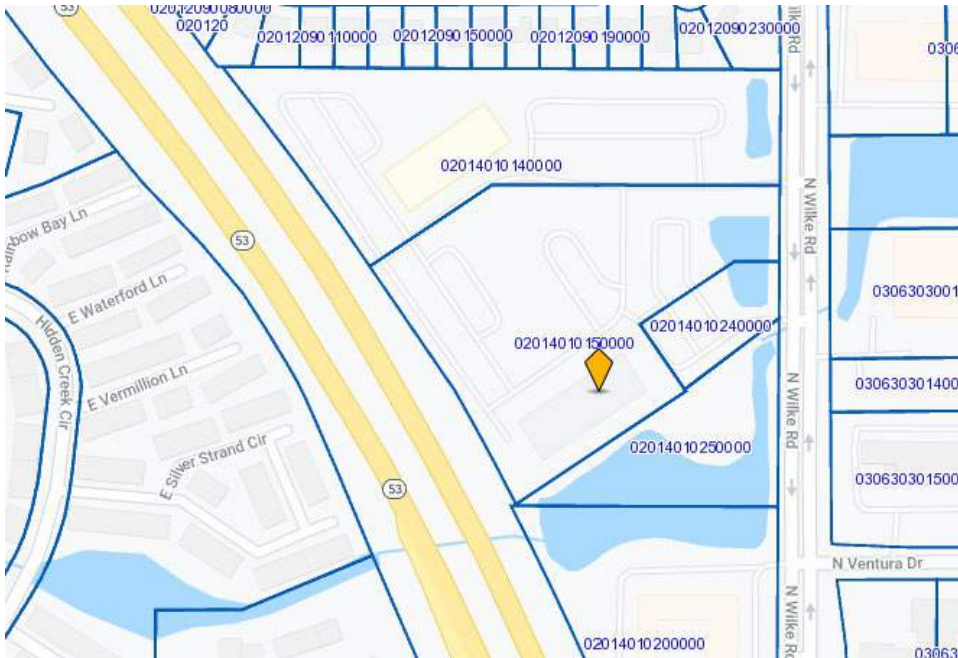

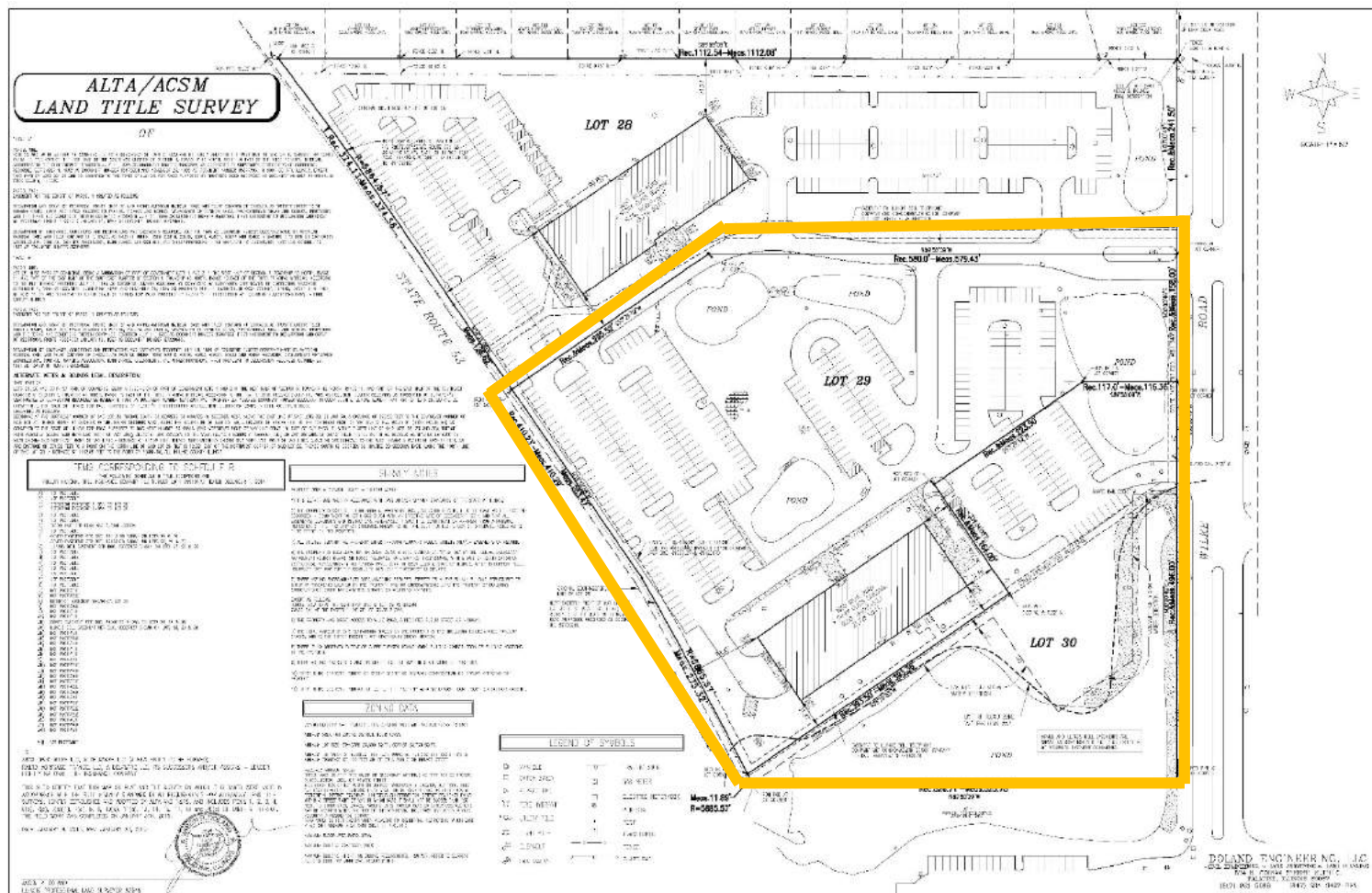
