



### **COMMUNITY IMPROVEMENT CORPORATION**

The Community Improvement Corporation (CIC) of Ashland is a local, non-profit, economic development corporation, assisting government entities and private businesses. CIC of Ashland partners with Ashland Economic Development, the City of Ashland, Ashland County, and MAGF, as well as private businesses, to promote economic development projects countywide. For approved projects, CIC of Ashland can purchase, resell, own, and lease real estate properties and business equipment, as well as facilitate projects by participating in outside funding, direct lending, or investing in private companies. Projects normally involve new business start-ups or existing company expansions that affect employment or provide other community benefits.

### **MOHICAN AREA GROWTH FOUNDATION**

Mohican Area Growth Foundation (MAGF) is a non-profit development corporation serving the Loudonville-Perrysville area in southern Ashland County, and the corners of four surrounding counties that share the area's heritage of industry, agriculture, and tourism surrounding Mohican and Malabar Farm State Parks. ### INCENTIVES

### **OHIO COMMUNITY REINVESTMENT** AREA (CRA) PROGRAM

Ashland's CRA provides real property tax exemptions for property owners who renovate existing or construct new buildings within the set boundaries. We have a city-wide community reinvestment area for Ashland.

### **OHIO ENTERPRISE ZONE PROGRAM**

Enterprise zones are designated areas of land in which businesses can receive tax incentives in the form of tax exemptions on eligible new investment.

### **EDUCATION & TRAINING**

Ashland County is home to Ashland University, a mid-sized private institution offering undergraduate and graduate programs to nearly 6,000 students. Ashland is also home to six public school districts, two affiliated career centers, and two private schools.

Workforce training programs are available through the Ashland County West Holmes (ACWH) Career Center and through Transformation Network, a non-profit community technology center. The ACWH Career Center also provides adult education and career enhancement course.





### **WORKFORCE**

In 2014, Ashland Economic Development conducted Business Retention and Expansion visits to over 40 local manufacturers. The visits uncovered a need for skilled workers. To address their needs, each Spring Ashland Economic Development hosts an annual Job Fair. With 300 job seekers attending in 2014, we helped pair the skilled laborers in Ashland with local manufacturers and businesses.

















